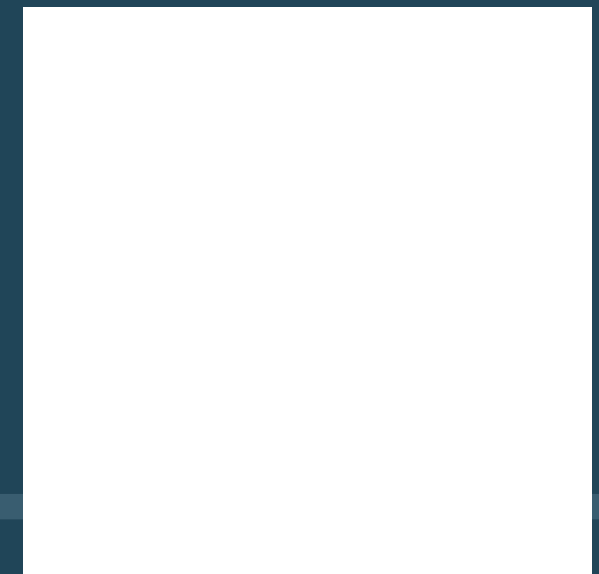
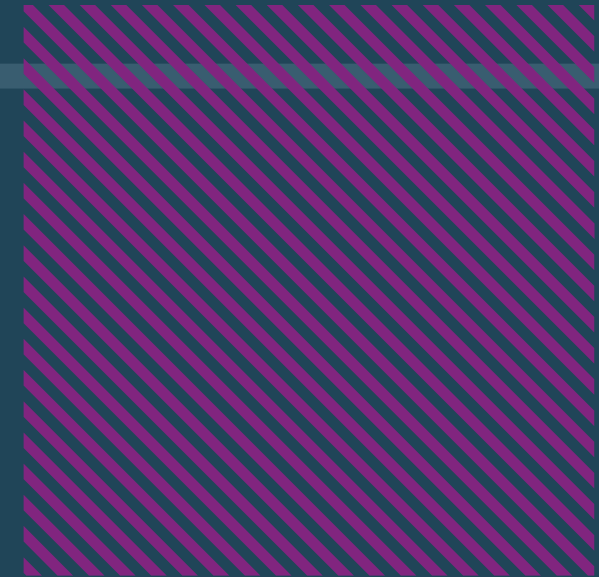

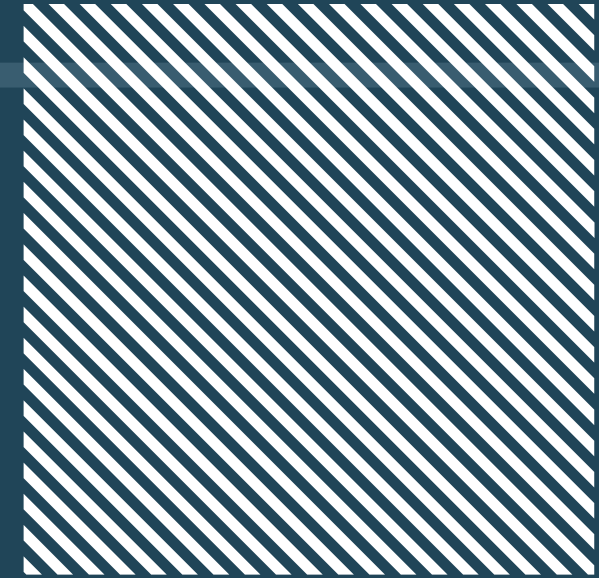
clear all unknowns!

KEY DATES

MAY 15

Local CIMV Day

Localities must ensure that compliance indicator reports yield accurate results for Part C MCs

MAY 16

State CIMV Day

Part C MCs will run individual reports for all localities for compliance indicators C1, C7 and C8; results on reports are those recorded and reported

MAY 23

April Verification Deadline

Last opportunity to inform Part C MCs of local correction of noncompliance of C7 and C8 and to request verification prior to notification

JUNE 13

CPN Deadline

Last opportunity to inform Part C MCs of local correction of noncompliance and to request verification prior to official notification

JUNE 30

Determination reports (copy 1 of 2) issued...triggering official notification of noncompliance (if warranted)

meet the (cinv) civet.

The civet is a small, lean, mostly nocturnal mammal native to tropical Asia and Africa, especially the tropical forests. The term civet applies to over a dozen different species, mostly from the family Viverridae. Most of the species' diversity is found in southeast Asia. Civets do not form a monophyletic group, as they consist only of certain members of the Viverridae and Eupleridae.
